#### 3. Review of Petitions

#### Petitioners;

#### A. 54 Turner Road- E. Harrison

Officer Grace read an email to the committee from Mr. Walker who is out on leave. Mr. Walker expressed concern that by closing off Turner Rd permanently, Cedar St will absorb all of the issues that Turner Rd residents experience. Cedar St is technically more narrow than Turner Rd. He recommends changing and posting both Cedar St and Turner Rd to 20 mph as well as adding "Children Ahead" signs. He does not recommend keeping Turner Rd closed once the culvert is fixed, nor does he recommend speedbumps.

Officer Grace shared that he is receiving the same complaints (speed, increased amount of traffic) on Cedar St as Turner Road.

Ms. Raffi recommended to table any votes on this so that we can spend a little more time researching the best possible options. Ideally, we need an overall plan for the town (would be amazing if this was done at state level) to determine how to best move traffic throughout the town. Right now, people are asking for solutions that are simply just moving the problem from one area to another. We have done a study at the Hollis/Highland/Prentice area, we're in the process of a study at Norfolk/Central, where are the other areas in town that need a study (we think Turner/Cedar/Ashland St.

She will work with Ms. Harrison and Selectwoman Hein to look more at incorporating Complete Streets to this area.

# 5. Discuss Handicap Parking Spot at 688 Washington St

Officer Grace reported that the former residents of 688 Washington St who needed the handicap accessible spot no longer reside there. He recommends that DPW move the spot to the front of St. Mary's Church.
